

If legal action is required due to noncompliance with provisions specified, the applicant/owner shall be responsible for all costs of the legal action, i.e., court costs, attorney's fees, etc. Enforcement of nonconformance by applicant/owner is outlined in the connection regulations.

## TYPICAL DRIVEWAY CONNECTION DETAILS



## Notes:

- 1. Driveway connections and sidewalk sections that will have vehicular traffic shall be constructed of 3000-PSI concrete and shall have a minimum thickness of 6".
- . Sidewalk sections not subject to vehicular traffic may be 4" in thickness
- The minimum width of sidewalks shall be 5'. In restricted conditions, the width may be reduced only with prior approval.
- . All joints around the perimeter of the driveway connection shall be <sup>1</sup>/<sub>2</sub>" and shall have a preformed joint filler. The driveway connection shall be considered all that portion of the driveway within the public rights-of –way.
- 1/8" open construction joints shall be place within the driveway connector and/or sidewalk at equal distance not to exceed 20'. Joints in curb and gutter to match driveway connector.
- . The driveway connector shall be uniform width within the right-of-way.
- All sidewalk surfaces shall have a maximum cross slope of 2%. Any slopes over 2% will have to be reconstructed unless it is infeasible as determined by the Public Infrastructure Department of the City of Tallahassee.
- . The maximum slope of the driveway connection (not including a sidewalk portion) shall be 10% perpendicular to the roadway, unless specifically approved prior the installation.
- 9. Sidewalks and driveway connections must conform to the slope of the roadway unless specific approval is granted.
- 10. Any sidewalk or curb and gutter that are damaged during a construction project must be replaced in accordance with City standards prior to a Certificate of Occupancy or Certificate of Completion being issued. It shall be the contractor's responsibility to ensure that the repairs are made and approved.
- 11. A formwork inspection must be made and approved before any concrete is placed for any sidewalk or driveway connection construction.
- 12. Rural turn out design may be required as determined by the City.
