**1102 South Adams Street** 1102 S Adams Street is a commercial shopping center located off the Cascades Trail within the CRA Greater Frenchtown Southside District. The owner, George Petrandis, applied for CRA funding in 2023 to assist with adding utilities to allow for a food truck to park on the east side of the building and to install a canopy over the deck on the south side of the building. The applicant worked with IGT Solar to create a solar canopy, which will now generate electricity for the building and provide shade cover over the deck. There are a variety of services offered by the tenants at 1102 S Adams Street and rotating food trucks on-site.
